New Updates (since last bulletin)

Land and Buildings Collection Tool

On 17th January the Land and Buildings Collection Tool goes live, with a deadline for submission of 21st Feb. This is the annual collection of information about academy land and buildings by the DfE. This year's data collection is based on a snapshot of land and buildings on 31st Aug 2022.

The collection does not apply to schools who are not academies, so if you aren't an academy or weren't on 31st August 2021 you can stop reading this!

Everyone else will be involved in some way in submitting information for this year's return, but that will look different for different schools. I have attached a summary with the bulletin of what it will look like for different schools for you to refer to if it is of help.

In all cases, because schools are on land owned by the Diocese of Hallam, the Diocese will need to approve information about church owned land. This will be part of the submission process, but to give time for this it is important that we complete our work as soon as possible, so that the Diocese can check their sections in good time for final submission on 21st Feb.

Schools that were single academy trusts on 31st August 2022, but joined St Clare's on 1st September have some additional options about how you submit. You will have received an email about this back in October. So that I can coordinate this with the DfE, I need to know if:

- You have already asked the DfE to submit the form on your behalf
- You would like the DfE to submit the form on your behalf but have not yet asked them (this option is probably best if you have changes to land and very few/no leases)
- You plan to complete the form in school when it goes live on 17th Jan (probably the best option if you think you have changes and/or quite a number of non-land leases)

I have flagged this up in the 'actions' section above for the schools this is relevant to. Please do let Anita know which of the options above applies to you by Tue 17^{th} Jan.

RAAC (Reinforced Aerated Autoclaved Concrete) survey

Thanks to everyone who has already completed the online <u>form</u> sent out by Anita on Monday 9th Jan. This form has only gone to schools who have joined St Clare as they are the schools we need to submit the information for.

Please note that there is no expectation from the DfE for you to be checking for the presence of RAAC. The data collection is just to find out which schools have already had a survey or have one planned, or those who already know that you have RAAC. It is to help the government plan the strategy for the future in managing this.

This week we have a couple of notices from St Alban's. The first is in relation to some vacancies that they have coming up. If you would like to highlight vacancies across schools via the bulletin, please let me know. Sharing vacancies directly with each other may help to identify opportunities to help one another out. It may be that you have strong trainees that you don't have a job for, or strong colleagues on fixed term contracts, or you may have had strong applicants for a post that you did not appoint. In all of these cases, it could be helpful to share this information with schools that have vacancies as a way of helping each other out. It may even be in some cases that vacancies could be filled through a secondment that would be beneficial to both schools, so going through the bulletin may help us to identify these different sorts of opportunities that are open to us as we develop out CMAT.

Also from St Alban's we have a request that any schools who have had experience of taking in refugees, particularly where there is no English spoken by the child or the family, to let me know. Again, this is another simple way of linking up experience across our families of schools to help one another out.

Finally I have included the notice about interns (along with the attachments) from last week. I would really encourage you to support promotion of the programme wherever you can and also to consider hosting interns this summer. It is a really good programme and we have seen some under graduate teachers commit to teaching as a career, many of whom trained with the SCITT and are now teaching in schools across the Diocese. It is a really good way to nurture and grow our own teachers. You can use the attached flyer to promote the programme and there is a link in the letter if you wish to register an interest in hosting an intern in the summer.
