COVID Guidance

A couple of you have been in touch about guidance in relation to Covid, given that cases are currently rising.

This is an area it is helpful having a Deputy Director for Healthcare as the chair of the Trust! Kev has kindly shared the following:

The Chief Medical Officer wrote out to schools earlier in the month with guidance: https://www.gov.uk/government/publications/letter-to-school-leaders-on-mild-illness-and-school-attendance

I would share this with families and I think the same rules should apply for staff: Schools are not health/ social care settings.

Cold/flu/ COVID symptoms shouldn't stop people coming to school. A raised temperature or severe symptoms are good reasons to stay home- as we would normally recommend.

Testing positive does not equate to being infectious and so I would be guided by symptoms rather than LFDs.

There is a rising level of COVID in the community so there will be more positive tests around.

Staff sickness absence should be managed in line with the normal policy with no different approach for days missed due to COVID.

Please note that the sickness absence policy already requires that absence triggers do not automatically lead to informal or formal action, but that each case should be considered on merit. This allows for reasonable judgement to be made where, for example, someone has had time off with covid or other flu like symptoms, so there does not need to be a different approach specific to Covid.

CIF Papers & SCA

I am aware that you will recently have received an email about CIF bids for this year. I can confirm that, for schools in the Trust this is no longer relevant and you can ignore the message. We have been in touch with the Diocesan property department to ensure that they have a clear picture of which schools this is relevant for and which schools it is not.

On the subject of School Condition Allocation (SCA) funding, we are approaching the end of our first 'bonus' window for applications. Thanks to those schools who have got bids in. Once the deadline passes, we will review the bids in line with the scoring criteria set out and get back to you.

We will then move into what will become the normal bidding cycle. While this process mirrors CIF to an extent, we will also be able to build up over time a picture of need and other areas for development so even where work is not funded immediately, we can add it to a longer term plan. The development of this plan will also be supported by the condition improvement surveys that we are commissioning.

Budget visits

Thank you to everyone who has already responded to our request to organise meetings in school with Adnan and I. These are for schools in the Trust only at this point and they are a follow up to the budget setting and forecasting work that we did over the summer term.

These visits will help us to identify more accurately where there is scope for savings this year and in the future and where there are areas that we must protect. It will also give us additional information to help with the statutory audit and our longer term financial strategy.

All the time, we are building up a more and more detailed understanding of each school. This is the first time we have had this understanding as a shared picture and it will enable to see where there are opportunities for efficiency savings, ways we can support one another in difficult financial times and ways we can ensure that we make the most out of our common resources in the areas that are most important to us.

Requests for information

Thank you for your continued responses to the requests for information related to the audit, governors and heads' reports, returns about the Trust mass, etc.

As we build up more information, we will need to ask less often and, as we develop ways for sharing data we aim to reduce the work associated with sharing information.
